





- North Carolina is a Smarter Balanced Affiliate Member but will administer its own statespecific tests in 2016-17.
- Louisiana law states that it cannot include more than 49.9% of questions based on the "blueprint or intellectual property developed by" PARCC or any other federally funded consortium on its state-specific test.
- Michigan plans to use a portion of Smarter Balanced items in its state-specific test.
- Massachusetts will move to a new test, MCAS 2.0, comprised of a portion of PARCC items in spring 2017.



This map is current as of January 2017 and will be updated as new information becomes available.




Notes:

- AK students must choose to take one of three tests prior to graduation: SAT, ACT or WorkKeys.
- CO is administering PARCC in grades 3 9 only
- HI administers the SBAC in ELA and math to all students in 11th grade. In addition, students take EOCs in Algebra I and Expository Writing and the ACT Plus Writing.
- ID students must choose to take one of three tests prior to graduation: ACT, SAT or COMPASS.
- The MI Merit Examination is made up of the SAT with Essay, ACT WorkKeys, and the M-STEP summative assessments in science and social studies.
- MA will move to a new test comprised of a portion of PARCC items in spring 2017. Districts that administered PARCC in spring 2015 will do so again in spring 2016. Others can choose PARCC or the current MCAS in spring 2016.
- ND administers the SBAC in ELA and math to all students in 11th grade. In addition, students must take either the ACT or WorkKeys prior to graduate.
- In NJ, to graduate, students must produce threshold scores on a test of their choice: PARCC, ACT, ACT Aspire, PSAT, SAT, Accuplacer, or ASVAB-AFQT, or demonstrate mastery by portfolio.
- In NH, in eight districts, students take Smarter Balanced once each in elementary, middle, and high school, and PACE assessments in all other grades.








- AL students take grade-level assessments in math and ELA with local option EOCs in both.
- DE students take the PSAT in 9th & 10th grade and the SAT in 11th grade; in math, there is also a local option to administer an EOC.
- FL students take EOC assessments in math and a grade-level assessment in ELA.
- IL students take EOC assessments in math and grade-level in ELA.
- MD students take EOC assessments in math and gradelevel in ELA.
- MA will create a "next generation" MCAS to include both MCAS and PARCC items. It will be administered beginning in Spring
- SC did not select a vendor for high school assessments. The legislature could intervene in January to select an assessment, which could be SAT or ACT or a continuation of currently administered EOCs.
- WA students take both EOC and grade-level assessments in math and grade-level in ELA.

Notes:

- NJ students in the classes of 2016, 2017, 2018, and 2019 can meet the requirements of demonstrating proficiency in math in several ways, including by achieving a passing score on PARCC Algebra I, Geometry or Algebra II or a Substitute Competency Test; or meeting the criteria of the NJDOE Portfolio Appeal. The state plans to require all students to take the Algebra II EOC prior to graduation. For ELA, students may achieve a passing score on a PARCC ELA assessment in grades 9, 10 or 11 or a Substitute Competency Test or meet the criteria of the NJDOE Portfolio Appeal.
- NY students must take and pass Regents exams in ELA and math. See <u>Achieve's State</u> <u>Assessment Resources</u> for more details about course and test alignment.
- OK students must pass 4 out of 7 end-ofinstruction tests (EOIs) to graduate: Algebra I and English II plus a combination of 2 of the following: Algebra II, Biology I, English III, and US History.
- OR students can demonstrate Essential Skills graduation requirements in several ways, including achieving a passing score on statewide assessments.
- SC did not select a vendor for high school assessments. The legislature could intervene in January to select an assessment, which could be SAT or ACT or a continuation of currently administered EOCs.
- TN districts have the option to factor EOC scores into course grades.
- WA EOC exams in Algebra 1/Integrated Math 1 and Geometry/Integrated Math 2 are based on previous Washington State Learning Standards. EOC exit exams are based on updated Washington State Learning Standards, beginning in 2014-15. The EOC assessments are available through the class of 2018 as one way for students to meet the state's graduation requirement in math.





- AK students must choose to take one of three tests prior to graduation: SAT, ACT or WorkKeys.
- HI administers the SBAC in ELA and math to all students in 11th grade. In addition, students take EOCs in Algebra I and Expository Writing and the ACT Plus Writing.
- ID students must choose to take one of three tests prior to graduation: ACT, SAT or COMPASS.
- IL districts choose one of three PARCC assessment combinations to administer to students. The state adopted the SAT to administer to all 11th grade students for the 2015-16 school year; however, ACT has filed a protest, and there is not yet a statewide assessment budget to pay for the SAT.
- The MI Merit Examination is made up of the SAT with Essay, ACT WorkKeys, and the M-STEP summative assessments in science and social studies.








States Requiring ACT or SAT for High School Students 2015-16








